Here is a list of information concerning the organization of next USIC Shooting Championship.

Information is separated into 2 parts: Organizational and Technical information

Please read carefully all these information and feel free to ask us if you need more precisions.

- **Organization Information:**

- Bring your toilet necessary (towels, soap, shampoo...). Our cottage and rooms are not equipped with.
- Only cash will be accepted at the bar
- Bring your swimsuit if you want to enjoy the swimming pool
- Transport of Weapons in France (remind from the invitation):

Entering France with a weapon:

The possession of a weapon of categories A, B and C by a resident of another Member State of the European Union: Austria, Belgium, Bulgaria, Cyprus, Croatia, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Lithuania, Latvia, Luxembourg, Malta, Netherlands, Poland, Portugal, Czech Republic, Romania, Slovakia, Slovenia, Sweden during a trip to France is subject to authorization, with exceptions. In all cases, the European Firearms Card is mandatory.

A sports marksman from another Member State of the European Union must meet the following conditions to travel to France (stay or transit) with a weapon:

Mandatory Documents:

European firearms card showing the weapon or weapons held

Written invitation or proof of registration for an official shooting competition mentioning the date and place of this competition

Licensed weapons: 6 category A, B, and C weapons and their feeding systems

The European card, written invitation or proof of registration must be presented in case of request from the competent authorities.

Each team must be in administrative and technical confirmation in order to be able to transport its weapons to France. It is your responsibility to take the necessary steps to achieve this compliance. If you need a supporting document to obtain these authorizations, please let us know as soon as

possible with the type of document you need. We will not be responsible for any refusal of entry into the French territory with your weapons.

➤ Visa (remind from the invitation):

Each participating team shall be responsible for obtaining their visas. For the personal invitation letter, please send us full names, date of birth, passport numbers of your team in a special table document, which we will send you later at least 2 months prior the championship. If we will receive your details later, we do not take responsibility for not obtaining a visa due to last request.

- **Technical Information:**

- We absolutely need your declaration of names and the discipline of each competitor
- One shooter can only compete in one discipline. Double starts are not permitted
- The output of weapons will only be on the firing point of the competition and after the authorization of the referee.
- Jean (clother) is forbidden for training or competition and for all shooters. In case of no respect, the shooter will be automatically disqualified
- Time for preparation concerning the 25m Pistol is maximum 3 minutes (precision and rapid-fire stages) (ISSF Rules).
- At the end of the match firing, the referee will control each weapon to be sure that they are safe.
- It will be forbidden to carry weapon outside of its case outside of the firing point.
- ISSF Rules May 2023 will be the references rules.
